

Privacy Policy

The Aspen Art Fair ("we," "our," or "us") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and safeguard your personal information when you visit our website at [www.aspenartfair.org] ("Site").

By accessing or using our Site, you agree to the terms of this Privacy Policy. If you do not agree with the terms of this policy, please do not use our Site.

1. Information We Collect

We may collect the following types of personal information when you visit our Site:
